- **Supply of seed (250 bags x 25kg, 6480 variety plus 250 bags x 25kg, 6479 variety)**
- **Supply of fertilizer (234 (30) variety x 6300 bags)**
- **Supply of Herbicides and insecticides (Atrazen = 2500 L, Lasse = 2500L and Kemprin 200 = 500L)**

- Tenders submitted after this date and time shall not be considered and tender forms that are incorrectly completed will result in the disqualification of that tender.
- Tenderers are to be registered for VAT.
- A company profile which is to include the names and identification numbers of all the directors must be furnished.
- A company founding statement
- An original SARS Tax Clearance Certificate and proof of VAT registration.
