- Certified ID Copy(ies) of Director(s) (not older than 3 months)


- Entity Tax Compliance Status PIN & Entity Tax Reference Number (in writing, either on the company profile or any entity document with a letterhead as issued by SARS)
- Declaration of Interest MBD4, MBD 8 and MDB 9
- Billing Clearance Certificate or Statement of Municipal Accounts (not older than 3 months)
- A certified copy or Original BBEE Status Level Certificate or original affidavit
- Original Tender Document
- Completed data base registration form (if not currently registered with Nyandeni Local Municipality)
- In case of a joint venture, an original valid Tax Clearance Certificate of both partners should be submitted as well as a signed agreement by both parties
- It should be noted that failing to attach the BBEE Status Level Certificate will result in the 20 preference points not being awarded
- **Registration on the Central Supplier Database (CSD) is compulsory (proof of registration should be provided in writing)**
- The provisions of Preferential Procurement Regulations 2017 will apply
